## BIKE SAFETY

When you ride your bike on campus footpaths, go slowly and remember to yield to pedestrians.

Always give an audible warning when overtaking a pedestrian.

Remember, they may not be able to see or hear you approaching. Their safety depends on your courtesy.

When you ride on the road your bike is a vehicle and therefore you must obey all traffic laws.

Watch for cars pulling out. Assume the drivers don't see you until you are sure they do.

Always use a strong headlight and taillight at night or when visibility is poor.

**Pedestrians have right of way on campus.**

## ON CAMPUS

Toilet, change and shower facilities are available at the following locations on campus:

**Building 111 - Curtin Stadium**  
If you are a Curtin Stadium member you can purchase a locker and shower pass for 6 or 12 months. Contact Curtin Stadium on **9266 7870**, email [healthandfitnessenquiries@curtin.edu.au](mailto:healthandfitnessenquiries@curtin.edu.au) for pricing and additional information.

**Building 217 - Cycle Hub**  
All genders change room with enclosed showers, 184 secure bike bays, 171 swipe card lockers and toilets.

**Building 410 - Medical School**  
All genders change room with enclosed showers, 30 secure bike bays, 44 swipe card lockers and toilets.

**Building 420 - Nesuto Curtin Hotel, Zamia Apartments and Curtin College**  
All genders change room with enclosed showers, 118 secure bike bays, 92 swipe card lockers and toilets.

**Bike Pods Building 160**  
20 secure bike bays, 34 key lockers, toilets, showers and charging points.

**Building 214**  
20 secure bike bays, 34 key lockers, toilets, showers and charging points.

**Building 315**  
20 secure bike bays, 34 key lockers, toilets, showers and charging points.

Please note, a physical key is required to access bike pods with key lockers, including B160, B214 and B315. These can be arranged by visiting the Security Office (Building 115).

**Lockers**  
All lockers are for end of trip facility users only. To apply to have access to these facilities added to your card please contact the Safer Community Team.

Please note, if your card needs to be physically encoded a visit to the Security Office (Building 115) will be required.

## BIKE SECURITY

Bike theft is a city-wide problem and Curtin University is not immune.

Bicycles can be extremely valuable and are the most frequently stolen type of property at Curtin University. Most bicycles stolen are either unlocked or secured with poor quality locks.

To reduce the risk of having your bike stolen and increase the chances of it being retrieved if it is, we recommend you take the following steps:

- Where possible use the secure bike racks on campus.
- Always use a quality lock to secure your bike to a bike rack. A U-lock is recommended.
- Report suspicious activity, particularly around bike racks.
- Photograph your bike and its serial number to keep for your records.
- Engrave your drivers licence number onto your bike. This will enable easy identification of ownership should the bike be recovered.

Please report all incidences of damage or theft to the Safer Community Team.

## E-RIDEABLE GUIDELINES

E-rideables, such as e-scooters, are welcomed on campus, under the condition that you adhere to the below laws as outlined by the Road Safety Commission:

- One person per device.
- A helmet is to be worn at all times.
- User must be 16+ years of age.
- A bell or verbal warning must be used when navigating around other path users.
- Lights and reflectors are to be installed and used when required.
- You may not exceed 10km/h on footpaths and 25km/h on local roads, bicycle and foot paths.

In addition to the above, we ask that you please follow these safety guidelines when on campus:

- E-rideables/electric bikes must not be stored in buildings, hallways, egress areas or stairwells.
- E-rideables/electric bikes may only be charged in the Bike Pods identified. Chargers should be tested and tagged prior to use on campus.
